1. Executive Summary

1.1 e-space current usage survey

Between 20th June 2007 and 28th September 2007 Manchester Metropolitan University (MMU) Library, as part of the [JISC](#) funded RE-space project, conducted a survey of all MMU academics and researchers to determine current awareness and usage of [e-space](#), the University's institutional repository for research output. The survey also aimed to establish views on general Open Access (OA) and Institutional Repository (IR) issues. The results of the survey will be used to inform future advocacy of the service and will be disseminated to the wider Higher Education (HE) community.

1.2 Key findings

Current awareness and usage of e-space

Before the survey, 83.9% of respondents had heard of e-space, however, 44.6% of respondents said they don't use it at all. The main reasons for not using e-space were lack of awareness and time. Of those who do use e-space, approximately half use it to deposit research only.

Facilitating increased usage

Greater awareness of benefits and clarification of copyright issues were the two main areas where respondents felt the library could help/enable increased usage of e-space. Email and Faculty or Departmental events were listed as the top two methods by which respondents would like to receive more information about e-space.

General perceptions about e-space

The majority of comments about the benefits of e-space were positive. Those respondents who currently use e-space felt it benefits the institution as a centralised location for the deposit of research output. It enables colleagues to gain access to each others work thus promoting collaborative research and from an individual point of view it helps to increase awareness of publications in order to advance personal research profiles. Some respondents who deposit their work in e-space were not sure how it benefited them.

The main area of concern was uncertainty about copyright issues. Concerns were also expressed regarding academic credibility and peer review and the ability to indicate the type of publication within e-space.

General perceptions about Institutional Repositories (IRs) and Open Access (OA)

The majority of respondents agreed that e-space is a showcase for MMU's research output, helps to increase the prestige of the University and exposes MMU's research to a global audience.

Whilst the majority of respondents also agreed with the concept of OA, their main concerns were about copyright and quality issues and that depositing research in e-space takes up too much time.

1.3 Conclusions

Respondents were generally positive towards the idea of IRs and OA and e-space is widely recognized amongst respondents. The main areas for concern are copyright issues and lack of time. In most instances, individual responses to address specific comments were not possible as respondents had not included contact details.

2. Introduction

Manchester Metropolitan University has had a repository project, [e-space](#), since April 2005 which led to the launch of its repository of research publications in October 2006. The project was led by Library Services as a natural extension of its role of managing information and assisting scholarly communication.

This survey was conducted as part of the RE-space project, a [JISC](#) funded project addressing key issues and challenges relating to repository enhancement: advocacy; content acquisition; embedding of the repository into University strategy and workflows. This is the first of two surveys being undertaken, the results of which will present formative and summative evaluation reports from a post-1992, multi-site and multi-discipline university that has outsourced its hybrid e-prints repository service.

3. Methodology

The aim of the survey was to determine current awareness and usage of e-space, as well as views on general Open Access (OA) and Institutional Repository (IR) issues amongst all Manchester Metropolitan University (MMU) academics and researchers.

3.1 Questionnaire

The questionnaire was compiled in collaboration with the Project Steering Group and divided into sections using the following rationale:

Introduction

- Why we're running the survey (*context*)
- What we want to know and why (*purpose*)
- What will happen with the results (*involvement*)
- What is e-space (*background*)

About you

- Who are they (*faculty/dept. information needed for targeting in future advocacy; option to remain anonymous may encourage participation*)

About e-space

- Have they heard of it, if so how (*inform future promotion/advocacy*)
- Do they use it and if so, what for (*establish current usage and if not used, why*)
- What would help them use it more (*how we can help*)
- What do they think are the benefits (*gauge perceptions to inform advocacy*)
- What do they think are the barriers (*gauge perceptions to inform advocacy*)

About IRs

- Views on benefits and barriers (*determine general views and raise awareness of issues; inform future advocacy*)

Further information

- Do they/how do they want further information (*how we can help; inform future promotion/advocacy*)

[Bristol Online Surveys](#) (BOS) software was used to formulate the survey and provide a URL link. This method was chosen as it was felt that offering an online survey would be an easy way to target the maximum number of people. This will be reviewed for future surveys which will also investigate the use of a paper based questionnaire to be distributed by library staff responsible for academic liaison.

The survey was launched on 20th June 2007 and ran till 28th September 2007.

3.2 Response rate

The survey was marketed through the all staff mailing list; researchers' mailing list; News section on the Library Website; link on the e-space homepage. Follow up emails were sent each month to the all staff and researchers' mailing lists.

The response rate (4%) was very poor and possibly can be attributed to the timing of the survey. The survey was launched two days before the end of the Summer term. The survey was left open until two weeks after the start of the Autumn term, however, this is one of the busiest times of the year for academics and although regular email reminders were sent, this didn't achieve the desired response.

The timing of this survey was dictated by the timing of the start of the project and although measures were taken to increase the response rate, they were unsuccessful. Timing will be considered as a major success factor in future surveys.

4. Survey Results

4.1 Number of respondents

Response rate: 4.1%

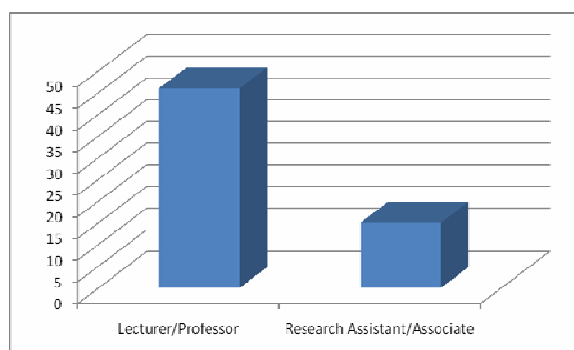

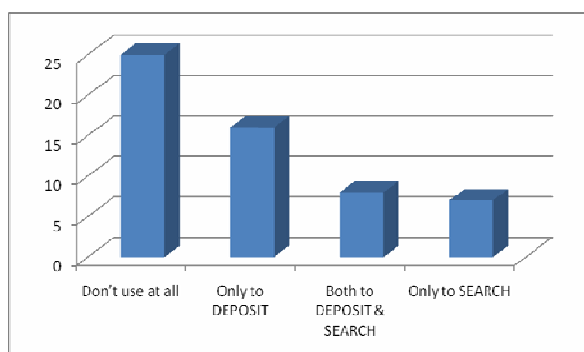

4.5 Views about e-space

- I do not know, I upload my publications in departmental solidarity to improve the portfolio of the department and institute online
- I don't know how it benefits anybody yet.
- I have directed people to e-space and also to find out other people's work.
- I have only used e-space once so far, this was to see what literature and research has been carried out around Equalities and Diversity subjects. This will help me and my new Team, to prepare for the EIA project at MMU
- I strongly believe that scientific information should be spread far and wide and be made available and shared with as many people as possible - in the interest of research in general and me personally. e-space is yet another way to disseminate my findings, and thus an opportunity to raise my professional profile. I think the e-space service is a great idea and very useful in this respect. I also think that it could help in increasing the university's profile and international standing if new publications were regularly posted on e-space.

- wider dissemination of research findings/ publications; first step towards "open access" publications

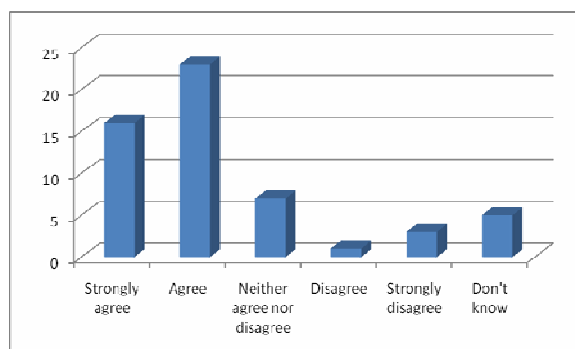

- what are we allowed to deposit there?

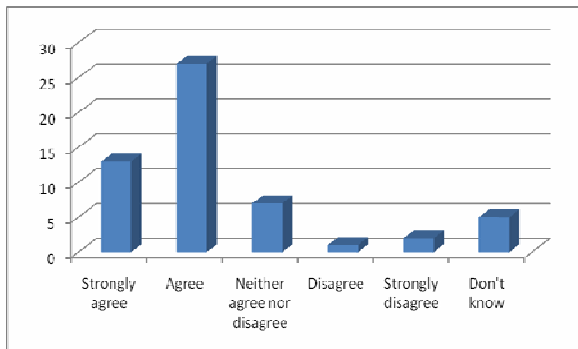

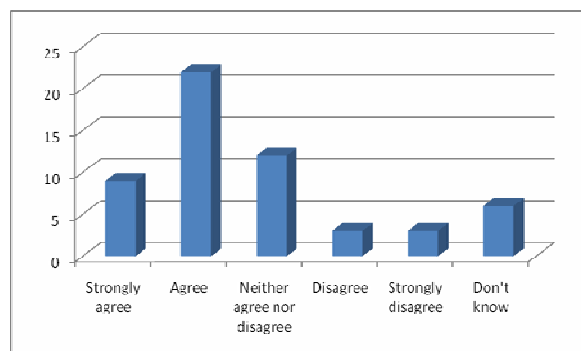
The IR exposes MMU's research output to a global audience



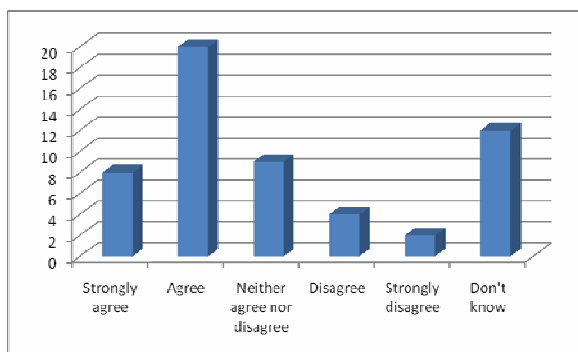

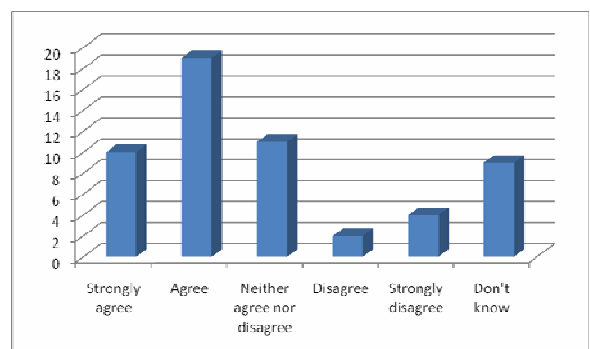
The IR helps increase citation rates to MMU's research output

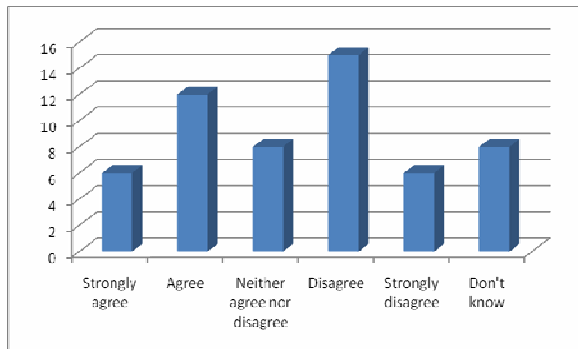
The IR will help with the RAE submission process

4.7 Views on perceived barriers to IRs

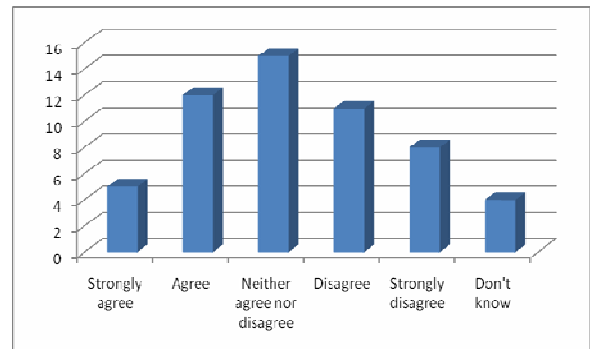
I'm concerned that depositing research output in an IR takes too much time



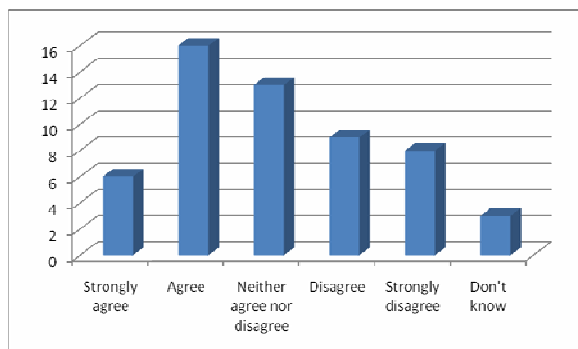

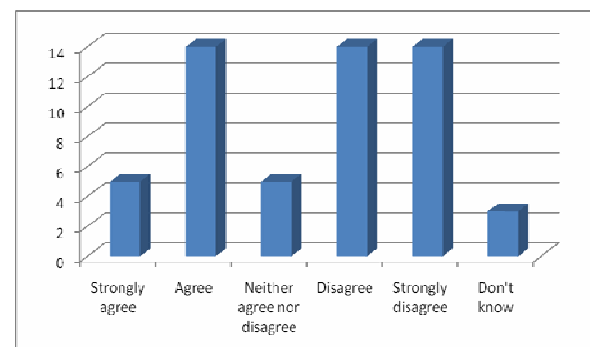
I'm concerned about quality issues and would rather just publish my research output in peer reviewed journals



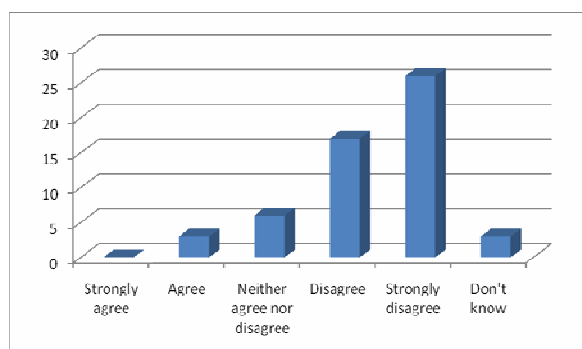

5. Conclusions and recommendations

Survey method and timing

The response rate to the survey was poor and we can assume that the timing of the survey, during the summer vacation and at the beginning of the academic year, had a significant impact on this. The decision to offer the survey as an online option only was made in order to increase distribution. Timing and multiple methods of distribution will be considered more carefully in future surveys in order to maximise both distribution and response rate.

Raising awareness of e-space

Although a high percentage of respondents had heard of e-space, just over half of these actively use it. The breakdown of respondents by Faculty indicates that awareness in some Faculties may be low. Those Faculties and Departments with a poor response rate to the survey and those with little or no content in e-space will be targeted for future advocacy and promotion in order to raise awareness of both the service and its benefits. Email, Faculty/Department event and Library presentation were identified as the preferred methods of communication of information. Appropriate Faculty/Department events will be identified as possible opportunities for future advocacy.

Issues for advocacy

The main areas of concern for respondents are greater awareness of the benefits of using e-space, understanding of copyright issues and lack of time to deposit material. These areas will be addressed in future advocacy and promotion. In order to enable library staff to advocate and promote the e-space service, general awareness sessions were delivered over the summer to library staff at all levels. It is proposed that a more in-depth training session will be developed and delivered to library staff responsible for academic liaison with the aim of increasing knowledge and confidence amongst library staff in order to facilitate more effective advocacy. This training will cover general awareness of the Open Access movement and will focus specifically on the benefits of using the e-space service, copyright issues and the role the library takes in providing a mediated deposit service.

Content acquisition

Help from Research Administrators and the Library were both identified as areas which would enable greater use of e-space. The mediated deposit service offered by the Library is the method used by the majority of e-space depositors. Future work will look at the role of Research Administrators in the deposit process. This will include identification of how deposit into e-space could become a part of research administrative workflows, including current processes for gathering research data and input into the University's Research Management System (RMS) and how the library/e-space could be informed of new research data.
