Note: The definition of 'retail monopoly' includes all villages where there was only one retailer as well as those where the only other retailer(s) were a totally different trade (e.g. a grocer and a butcher; or a baker and a grocer). Whilst this cannot take account of any retailing of goods beyond the primary trade, which went unrecorded in the trade directories, it does ensure that the definition of monopoly represents a maximum rather than a minimum.
